OUR VISION:


PIC's vision is for all children to fulfill their potential to succeed. **OUR UNIQUE ROLE:**



Special Education Resource Video Project


The Parent Information Center of Delaware received a generous grant from the Longwood Foundation to help create a video project around topics such as: "Five Steps in Special Education", "Eligibility for Special Education", "Preparing for IEP Meetings", & "Age of Majority". These 3-6 minute videos will be hosted on PIC's website and are currently hosted on our YouTube channel. Our hope is that through this project, we can reach a larger audience and provide more bite-sized, parent-friendly information. We are currently working on creating a second set of videos.

Do More 24 Success

For the first time PIC participated in Do More 24 Delaware, a 24 hour day of giving that raises funds for local non-profits. The success of this campaign enabled PIC to direct funding to our new Transition Advocacy Project and Early Intervention Initiatives.
