## Our Support & Services

One-to-One Consultations provide parents and caregivers with the information and skills necessary to ensure their children receive free and appropriate special education and related services as guaranteed them under the IDEA

## What is the Individuals with Disabilities Education Act?

- Federal education law
- Protects the rights of eligible children with disabilities ages birth to 21 (Early intervention services for babies and toddlers to school-age special education services)
- Requires that eligible school-age children with disabilities are provided with a free appropriate public education (FAPE) or special education





## What is Special Education?

Special education: specially designed instruction to meet the unique needs of a child with a disability

Related services: developmental, corrective, and other supportive services as required to assist child with a disability benefit from special education





## 5 Important Steps about the Special Education Process

- 1. Identification
- 2. Evaluation
- 3. Eligibility





- 4. IEP
- 5. Procedural Safeguards



#### **#1 Identification**

Ways in which children are identified as possibly needing special education and related services:

- Child Find School District
- Parent or Educator
- RTI or (Response to Intervention)





#### **#2 Evaluation**

- Procedure to determine if child is a child with a disability per special education law
- Using multiple data sources
- Written parental consent required for educational evaluation
- Eligibility determined within 45 school days or 90 calendar days, whichever is less, of receiving written parental consent



## # 3 Eligibility

- Autism
- Deaf-Blind
- Developmental Delay
- Emotional Disability
- Hearing Impairment
- Intellectual Disability (Mild, Moderate, Severe)
- Orthopedic Impairment



- Other Health Impairment
   (may see Physical Impairment)
- Preschool Speech Delay (3 & 4 year olds only)
- Speech/Language Impairment
- Specific Learning Disability
- Traumatic Brain Injury
- Visual Impairment



#### **#4 IEP**

#### Document and Process – developed 30 days after eligibility

- Student Information
- Data Considerations
- Transition (for students turning 14 or entering 8<sup>th</sup> grade)
- Needs, Services and Annual Goals
- Additional Considerations (transportation, statewide assessment, discipline twelve-month program, extended school year services)
- Least Restrictive Environment/ Placement



## **REQUIRED IEP team members**

- Parent
- Child when appropriate
   (must be invited to their IEP meeting when turning 14 or entering 8<sup>th</sup> grade)
- General Education Teacher
- Special Education Teacher
- Representative of School/District
- Individual who can interpret evaluation results
- Others at discretion of parent or school





### **#5 Procedural Safeguards**

- Provide consent for educational evaluations
- Work with a school team to determine eligibility for special education services
- Participate in IEP (Individualized Education Program) team meetings
- Receive notices of meetings and progress reports
- Examine records
- Participate in manifestation meetings
- Agree or disagree with special education services
- Agree or disagree with educational placement
- Use conflict resolution options



## Age of Majority

- Age 18
- IEP team determines the student's ability to provide informed consent related to the student's educational decision making.
- The team must consider all three of the following:
  - 1) The student is generally able to understand the basic components of the student's IEP
  - 2) The student can use the information provided to make a decision
  - 3) The student understands that the student can say yes or no



## Age of Majority – Able to provide Informed Consent

A student determined to be able to provide informed consent in connection to the student's educational decision making may choose to:

- 1) Assume and exercise his/her educational rights OR
- 2) To voluntarily authorize an adult to become their Educational Representative using a power of attorney or by using a "Voluntary Grant of Authority" form developed by the Dept. of Education



## Age of Majority – NOT able to provide informed consent

If IEP team finds student is *not* able to provide informed consent:

IEP team will appoint an adult to serve as an Educational Representative (using descending order of priority given first to a willing and available biological or adoptive parent, and then to a wiling and available adult relative)

#### OR

If there is no willing and available biological or adoptive parent or adult relative, the team will refer the case to the Dept. of Education for the appointment of an Educational Representative through the Educational Surrogate Parent Program.
