**Steps to Prevent Bullying: Notifying the School** 

Parents should notify school staff each time their child informs them that he/she has been bullied. Parent Information Center of Delaware (PIC) has created a letter (see reverse) that may be used as a guide for notifying your child's school.

This letter should not be used to replace any district reporting forms. In addition to the letter, please refer to your school's code of conduct and/or bullying policy for additional forms/steps that may be required.

**Documentation is key.** Remember, if it's not in writing, it doesn't exist. Please be sure to keep a copy of the letter(s), and any forms submitted, for your records. This can be used with the bullying log to keep an accurate timeline of incidents.



Delaware requires all reported incidents of bullying, substantiated or not be reported to the Department of Education within 5 working days pursuant to Department of Education regulations.



Delaware requires that a parent, guardian or relative caregiver (as defined by statute) or legal guardian of any target of bullying or person who bullies another as defined herein, be notified.

## **SAMPLE LETTER**
